### Bring Diversity to the Labor Movement

Formative experiences within her family's history in the United States have led Chi-Ser, the eldest child of Khmer Rouge refugees, to pursue a career advocating for underserved communities. Having grown up under the veil of threats of violence to her family's Chinese takeout restaurant in West Philadelphia, she remembers that it did not always feel like the "City of Brotherly Love." From a young age, the responsibility fell to Chi-Ser to help her parents navigate countless legal and financial issues.

Over the years, she witnessed many immigrant families face challenges due to their limited English proficiency, misunderstandings, cultural unfamiliarity with navigating certain legal rights. Throughout her work experience, Chi-Ser has consistently sought opportunities directservice, national policy, and civil rights organizations. Through her work and volunteer experiences, she developed a critical understanding of systemic issues and the need for adequate access to legal rights and resources.

During her undergraduate years at New York University, she was a voting rights intern, documenting Asian American voting patterns and barriers, monitoring poll sites, conducting exit polls during



the 2008 Presidential Election, and conducting volunteer trainings for youth groups in New York City. Chi-Ser became a Voting Rights Organizer for the Asian American Legal Defense and Education Fund (AALDEF), where she coordinated a 14-state multilingual exit poll project (Asian American Election Protection Project) managing the recruitment, training, and placement of over 850 volunteers who surveyed more than 9,000 Asian American voters during the 2012 Presidential Election. This was the largest project of its kind

to-date. This project culminated in the filing of voting rights complaints with various government agencies, as well as her public testimonies before the New York City Council and the NYC Voter Assistance Advisory Committee.

Chi-Ser now hopes to apply her considerable experience and skills to benefit the needs of workers. She is a 1L student at the Temple University Beasley School of Law and will work as a Peggy Browning Fellow in the U.S. Department of Labor's Office of the Solicitor in Philadelphia, PA.



# Margaret A. (Peggy) Browning

A Beacon for Workers' Rights

Our namesake was, by all accounts, an exceptional person whose life and qualities left their mark upon the legal community and on the national scene. Born in Tennessee and educated at Swarthmore and the University of Pennsylvania Law School, Peggy was a creative and dynamic attorney.

While her name could have graced the masthead of any mega law firm, she chose to devote her energies to workers' rights. In her defense of workers' interests, she never lost a case in the Third Circuit Court of Appeals. Peggy was tirelessly focused on issues such as union representation, fair and equal pay and decent working conditions.

Her achievements strongly justified President Clinton's nomination of her as the first union-side lawyer in history to be appointed to the National Labor Relations Board.

The Peggy Browning Award is presented annually to social justice champions who have distinguished themselves with passion and dedication to the rights and needs of workers and their families.

focused on more lucrative pursuits in corporate law, and with many law schools cutting back on teaching courses such as Labor Law.

The Peggy Browning Fund provides this support in many ways, through our Summer Fellowship Program, our National Law Students Workers' Rights Conference, networking opportunities and now through these regional workshops. We appreciate the support of the law schools, local practitioners and academics who have provided the venues and participated on panels for the regional workshops. But most of all, we appreciate your support of all of our programs, helping us to continue encouraging progressive law students by showing them that it is possible to embark on a fulfilling career in public interest labor law.

### **Advocating for Workplace Justice**

### Support Progressive Law Students

Newly branded "Advocating for Workplace Justice," regional workshops introduce law students to PBF's Summer Fellowship Program and to the benefits of practicing labor law. The pilot workshop, held in February 2013 in Pittsburgh, was planned by Richard Brean, Esq., General Counsel, United Steelworkers, PBF Board member and now Co-Chair of the Regional Workshop Committee. Since then five workshops have been held in Ann Arbor, Austin, Boston, Los Angeles and Newark, with an average attendance of 24 students.

Panelists include union leaders, labor and plaintiff lawyers, labor professors, worker center directors, representatives from government agencies regulating the workplace and PBF alumni.

The last workshop was held on February 10, 2014 at Rutgers School of Law-Newark, where more than 20 students braved the snow to attend. The lead organizers of the workshop were moderator Gwynne A. Wilcox, Esq., Levy Ratner, P.C., PBF Board member and Co-Chair of the Regional Workshop Committee; and Co-Presidents Piel Lora and Meredith Wood Doherty of Rutgers' Labor and Employment Law Society. Eight more workshops are planned for this fall.

## 2014 Alumni



Briana Beltran, PBF '09 Advocating for Migrant Workers

Briana's father arrived in the U.S. from Mexico when he was 12 and he spent most his younger years working as a farmworker with his family. While her life was different, she grew to understand the issues faced by immigrants in the U.S.

Since middle school, Briana has been involved in organizations that work for immigrant rights. In law school, she became a PBF Fellow at the National Day Laborer Organizing Network in Los Angeles. "This was my first legal experience working with lowwage, immigrant workers and I was grateful to have had the support of the PBF," said Briana.

Today, Briana continues to represent migrant farmworkers as a staff attorney for Southern Migrant Legal Services in six states: AL, AR, KY, LA, MS, and TN. She assists with cases ranging from wage and hour issues to employment discrimination to trafficking. She's learned that forcedlabor trafficking is not as highly reported as other trafficking in this country and it's difficult accessing responsive and receptive government services in the southern U.S. Among the challenges of representing the victims is there's not always a great or helpful answer to their problems.



Matthew Blumin, PBF '06 Mentoring PBF Fellows

While many Peggy Browning Fellows have a long family history of involvement in the labor movement, Matt Blumin is typical of many others. He got a small taste of organized labor as a teacher and a union member, but had no exposure to labor law until he became a PBF Fellow at the Department of Labor in Philadelphia. It was there Matt discovered that he really enjoyed labor law.

With fewer law schools teaching labor law, many students aren't exposed to the field. PBF fills that gap. Matt also found that being a Peggy Browning Fellow sent a strong signal to potential employers that his commitment to workers' rights was serious.

One of those employers was Friends of Farmworkers, another PBF mentor organization. After graduating from law school and completing two judicial clerkships, Matt entered a year-long fellowship with Friends of Farmworkers where, among other assignments, he supervised that year's PBF Fellow. He went on to become an associate at Bredhoff & Kaiser, PLLC in Washington, D.C., before moving to his current position as Associate General Counsel at AFSCME.

Matt is pleased to note that one of his former roommates will be a PBF Fellow this summer. He also looks forward to mentoring this year's PBF Fellows at AFSCME.

At his law school commencement, Michael was presented with the David T. Link Award for outstanding service in the field of social justice and the ABA/Bloomberg BNA Award for Excellence in the Study of Labor and Employment Law. In addition, he received the Sister Jean Lenz Award, which is given annually to a graduate student who displays leadership in promoting a more diverse, inclusive campus community for students.

After graduation Michael returned to his home state and joined the union-side labor law firm of Sugarman & Susskind, PA in Miami, FL. His practice focuses solely on the representation of working people, their unions, and their benefit funds.

### Julie Polakoski-Rennie, PBF '08 From an International Perspective

After law school, Julie became a Fulbright Scholar at Victoria University of Wellington in New Zealand. There she conducted research in international comparative labor law studying the impacts of legal reform on the collective bargaining rights of blue-collar workers in New Zealand and the U.S.

She then began working for the Finsec Union organizing bank and finance workers. That's where she met her husband, and then moved to the U.S., where she started her career at the National Labor Relations Board (NLRB), Regional 2.

As a board agent/field attorney, Julie actively enforces the National Labor Relations Act before Administrative

Law Judges and in federal district court. She investigates allegations of unfair labor practices under the Act and makes recommendations to their regional director, as well as writing pre- and post-election decisions for the Region. She notes that she is continuously learning and being challenged in this enforcement role, particularly since the NLRB's Manhattan office is one of the busiest in the country.
