## **Organizing Is In Her Blood** Sees Vital Link Between Workplace Power 양 Community Power

This year's Summer Fellowship Program has placed 75 law students in paid summer fellowships. There they will acquire hands-on experience advocating at unions, worker centers, non-profits and union-side law firms for thousands of workers and their families. Sochie Nnaemeka is a member of the 2016 Class of Fellows and is entering her third year at Georgetown University Law Center.

Sochie has been involved in workers' rights organizing since she was at Yale College where she received a Bachelor's Degree in History and Women's Gender and Sexuality Studies. She began with community organizing for the Connecticut Center for a New Economy, through which she became involved with the local unions in New Haven, CT.

After college, Sochie was a union organizer for two years in Miami, FL, where she organized casino workers and identified and helped train leaders who were predominantly immigrants and workers of color. "It became clear to me that workplace power is strengthened by community power and vice versa," stated Sochie. "The same forces that allow employers to retain all bargaining power in the shop often conspire to

keep workers from living lives of dignity in their homes, schools, and neighborhoods."

Sochie continued her work with UNITE HERE! organizing hundreds of students, workers, elected officials and the unemployed at the intersection of workplace and community organizing, working and then leading campaigns for inclusive development, local hiring, community benefits agreements and good jobs. In 2014, she decided to attend Georgetown University Law Center to gain legal tools to continue to fight alongside working people for economic, racial and social justice. She is now entering her third year and has interned with the Center for Popular Democracy in New York and served as a law clerk in the General Counsel's office of the AFL-CIO. She will be spending this summer with the Los Angeles Black Worker Center Project.

## A Beacon for Workers' Rights

Our namesake was, by all accounts, an exceptional person whose life and qualities left their mark upon the legal community and on the national scene. Born in Tennessee and educated at Swarthmore and the University of Pennsylvania Law School, Peggy was a creative and dynamic attorney.

While her name could have graced the masthead of any mega law firm, she chose to devote her energies to workers' rights. In her defense of workers' interests, she never lost a case in the Third Circuit Court of Appeals. Peggy was tirelessly focused on issues such as union representation, fair and equal pay and decent working conditions.

Her achievements strongly justified President Clinton's nomination of her as the first union-side lawyer in history to be appointed to the National Labor Relations Board.

The Peggy Browning Award is presented annually to social justice champions who have distinguished themselves with passion and dedication to the rights and needs of workers and their families.

special focus has been broadening the impact of PBF's core outreach intiative the Regional Workshop Program. The dual purpose of the program is to interest law school students to both apply for Peggy Browning Fellowships and pursue careers in a broad range of practice settings devoted to securing working people their full measure of rights and protections under the law.

Each Regional Workshop involves a panel discussion, co-sponsored by PBF and the host law school led by a moderator, usually a law professor, and followed by students networking with the panelists and the other lawyers in attendance. The panels are comprised of a former Peggy Browning Fellow, who explains the fellowship application process and the broad range of paid summer placements available, and lawyers working at federal and state regulatory agencies, worker centers, law firms, union legal

Each panelist explains the challenges

at Pitt Law School, PBF then co-hosted four workshops in 2013 and ten in 2014. By 2015, the program had grown to its current twelve law school format with panels being mounted at UC Berkeley, U. of the District of Columbia, Florida, Northeastern, North Carolina, Notre Dame, NYU, Rutgers, Southern U., St. John's, USC, and Washington U. This fall, the committee is planning twelve more workshops at the following law schools: Alabama, Drexel, Fordham, Harvard, Georgetown, Miami, Michigan, Ohio State, Southern U., Stanford, UCLA, and U. of Washington.

We thank the nearly 150 lawyers who have volunteered to participate in the Regional Workshop Program. Their involvement has proven to be of enormous value to the law students and has increased PBF's fellowship applications at the participating schools. **Finding Solutions for Working** People

Kelvin has seen the importance of unions as a member of the American Federation of Teachers (AFT). As a teacher during the 2008 recession, he and his coworkers fought to keep their wages and benefits when state legislators sought to reduce the budget by "gutting" teachers' incomes. Teachers contacted their legislators and organized rallies. Their collective efforts curtailed the budget cuts.

Kelvin saw productivity and profits for companies growing while wages remained stagnant so he decided to become an advocate for employees. He attended law school at Catholic University of America and was awarded a PBF fellowship with the Teamsters where he learned that grievance procedures can be a powerful tool that can rectify small issues to wrongful terminations.

After graduation, Kelvin was an Assistant District Attorney in the Philadelphia District Attorney's Office. He recently became an associate at Osborne Law in Washington, DC, where he spends his days pushing himself to find solutions for working people.

**Representing Unions and Affiliated Employee Benefit Funds** In Borger, TX, as a high school and college student, Mark prepared arbitrations when he worked in Phillips 66 oil refineries and was an IUOE Local 351 member. The closest labor attorneys were 650 miles away, so arbitration prep was left to Mark. This gave him insight into the role attorneys play in the labor movement.

Mark attended William & Mary Law School and received a PBF fellowship with the Chicago Newspaper Guild. The skills he learned during his fellowship proved invaluable as he began to practice law at Previant, Goldberg, Uelmen, Gratz, Miller & Brueggeman. There, he represented unions in grievance arbitration, interest arbitration, and petitions before the NLRB. Mark then made his way to Florida where he is now an attorney with Mierzwa & Floyd, P.A., and represents unions and affiliated employee benefit funds.

Linelle Mogado moved to California after graduating law school. With few labor connections, she called Mary Anne Moffa at PBF who introduced Linelle to Kim Wirshing, in-house counsel at then-HERE Local 2 in San Francisco. After volunteering with the local of mostly immigrant hotel workers, and due to lockouts at 14 hotels in San Francisco, Linelle was put in charge of running their picketing headquarters so that the staff could be on the street. The experience was stressful, resolve-testing, and amazing. The strike became part of the backdrop to UNITE HERE!'s campaign 'Hotel Workers Rising!' which is active in North America today.

Linelle then went to work for Weinberg, Roger and Rosenfeld on wage-andhour class actions for farm workers, construction workers, and janitors throughout California, Arizona and New Mexico. She decided to return to her native country of Canada and worked as in-house counsel at the Professional Institute of the Public Service of Canada, then with UNITE HERE!'s local in British Columbia. "It was impossibly long to gain the credentials as a 'foreign-trained' lawyer in Canada, but after 2 1/2 years I did it!" Linelle recently joined the staff of the 46,000 member Hospital Employees Union in Vancouver where she specializes in workers' compensation appeals and assists workers who have been denied long-term disability benefits. She is licensed in two Canadian provinces and maintains her California Bar membership.


