A Beacon for Workers' Rights

Our namesake was, by all accounts, an exceptional person whose life and qualities left their mark upon the legal community and on the national scene. Born in Tennessee and educated at Swarthmore and the University of Pennsylvania Law School, Peggy was a creative and dynamic attorney.

While her name could have graced the masthead of any mega law firm, she chose to devote her energies to workers' rights. In her defense of workers' interests, she never lost a case in the Third Circuit Court of Appeals. Peggy was tirelessly focused on issues such as union representation, fair and equal pay and decent working conditions.

Her achievements strongly justified President Clinton's nomination of her as the first union-side lawyer in history to be appointed to the National Labor Relations Board.

The Peggy Browning Award is presented annually to social justice champions who have distinguished themselves with passion and dedication to the rights and needs of workers and their families.

Former Fellows Offer Valuable Skills

At AFSCME, Judy Rivlin offered her thoughts on hiring PBF alumni, "The Peggy Browning Fund attracts highly motivated law students who receive excellent and extremely practical training during their fellowships. I have hired PBF students as summer clerks for over 20 years, and they have been consistently top-performing. Now, when I need to hire a lawyer and I see a PBF experience on an applicant's resume, that applicant will always get very serious consideration.

As an AFSCME leader told me: 'Alumnus [X] was our labor representative for a few years, and did wonderful work for us. He recently relocated, but if he is an example of the Peggy Browning Summer Fellowship Program, I would be excited to have another alumnus consider a position with our union!"

Alumni Chapters Support PBF Programming

PBF is fortunate to have a substantial group of active alumni who are focused on developing future worker advocates by participating in our programs and mentoring our fellows. In 2019, alumni are planning several activities for alumni and fellows to meet, network, learn, and have fun.

PBF alumni are also mentors to students in law school through our Alumni Mentorship Program. Last year PBF alumni were paired with 45 students interested in entering the labor law field. In addition, every year PBF organizes teleconferences for Summer Fellows to learn about different areas of labor law that they may practice during their Summer Fellowships. This year, at least ten PBF alumni will facilitate teleconferences on various topics such as 'How to Get the Most From Your Summer Fellowship,' 'Advocating for Immigrant Workers' Rights,' 'Get To Know the National Labor Relations Act,' and 'Labor Law Jobs on Capitol Hill.'

Alumni Highlights

Peggy Browning Fellows Reflect on Their Experience

Meet Our First 3-Time Fellows

The Peggy Browning Fund is proud that we have provided over 1000 Summer Fellowships to law students since 1998. Each student was awarded a fellowship because of their outstanding qualifications as well as their interest and commitment to workers' rights.

For the first time this year, two students are receiving their third PBF fellowships: Flor Garay, a 3L night student at the University of the District of Columbia David A Clarke School of Law and Patrick Foote, a rising 3L at Chicago-Kent College of Law.

Both Flor and Patrick can attest to the broad spectrum of experiences PBF Summer Fellowships provide students.



"For my first PBF fellowship, I worked with the Workplace Justice Team at Make the Road New York. It was a life changing experience as I witnessed immigrant workers in the Queens area, organize to push for greater protections in the workplace. This experience taught me that our victories in court are really the community's victories.

My second PBF fellowship was at the United Food and Commercial Workers International Union (UFCW). As an intern for UFCW I worked on several research projects, including a public comment against a proposed rule to increase the speed line to process chickens at slaughterhouses. This was a very important project for me and for UFCW as it represents hundreds of workers in the meat and processing plants. Many of these workers are immigrants and undocumented workers who are at a higher risk to suffer from repetitive motion injuries, amputations, and other work related injuries that often go unreported and uncompensated.

This summer I will be working with the American Federation of State, County, and Municipal Employees Union (AFSCME). I am looking forward to learning about the local and national legal battles public sector workers face." Flor Garay, JD'20



"My first PBF fellowship (Summer 2018) was with the National Federation of Federal Employees (NFFE) and my second (2018-2019) was with the Chicago News Guild. Both were very different and gave me a good idea of the diverse set of tasks facing union lawyers.

Less than a week into my time at NFFE, the U.S. President issued three Executive

Orders that directly affected the rights of federal unions and their members. The majority of my time at NFFE was spent working on a lawsuit against the administration. It was an incredible crash course in federal labor law.

At the Chicago News Guild my work was focused on directly serving members. I did research into legal questions, helped the local participate in the News Guild international elections and worked on multiple arbitrations.

This summer I will be working with Communication Workers of America (CWA). I have a deep connection to CWA from before law school when I was a journalist. Then, we organized our workplace with the News Guild, a CWA affiliate."

Both Flor and Patrick plan to use their PBF Fellowships as a foundation to advocate for workers' rights after graduation.

Flor shared, "I would like to continue to be an advocate for workers wherever I go. It could be as an in-house attorney with a labor union, a labor organization, or finding a worker center that adopts a non-traditional model of empowering workers."

"My goal is to work for a union after law school, whether as an attorney or a business agent. I hope to continue to demonstrate my dedication to the union movement, familiarity with labor law and experience negotiating and navigating collective bargaining agreements."

2019 Regional Workshops



PBF's Regional Workshops Program, entitled *Advocating For Workplace Justice*, is held annually at law schools across the country and consists of a one-hour panel discussion followed by a one-hour networking reception. Panelists include union lawyers, labor law firm attorneys, labor law professors, Peggy Browning Fellowship Alumni and attorneys from the U.S. Department of Labor and the NLRB. **PBF is currently organizing 18 regional workshops for this fall. 
