# **Summer 2020 Proves Challenging For PBF and Mentor Organizations**

#### All 91 Fellowships Transitioned to Meaningful Experiences

Planning for the 2020 season of PBF Summer Fellowships was mostly completed when the pandemic hit and the country shut down. PBF had awarded 91 fellowships at unions, union-side law firms, worker centers and non-profit organizations - the largest class of fellows in our history.

Fortunately, most of our mentor organizations transitioned to having their Summer Fellow(s) work from home. New mentor organizations were added as needed, so all 91 fellowships were implemented. As this year's fellows worked remotely to assist workers and their families, many have stories to tell of their experience during the pandemic as well as the Black Lives Matter movement. Mollie Ponds is a rising 2L at Southern University Law Center. She rates her Summer Fellowship with the New Orleans Worker Center for Justice (NOWCRJ) as nothing short of rewarding and purposeful. NOWCRJ provided her with legal exposure to the challenging field of

fighting racial injustices and providing community resources every day.

One of the many highlights from this summer was being appreciated and knowing that she was valued and invested in from day one. She now sees the importance of workers' rights and labor movement attorneys. Her supervising attorney knew that immigration law was a high interest of Mollie's and did not think twice about providing her the

### Pandemic and the Future

#### Your Help is Needed

These times have become very challenging for everyone and we recognize how we all have had to transition to working from home and how staying safe at home has placed a tremendous burden on the labor community. The coronavirus pandemic has created a very serious financial challenge for the Peggy Browning Fund. Since its founding in 1997, the PBF's principal source of revenue has been hosting awards

receptions honoring labor leaders and attorneys representing workers and unions. These events are held each year in New York, Philadelphia, and Washington, and every other year in Chicago, Los Angeles, and San Francisco.

This year, we anticipated holding four awards receptions from January through June. The San Francisco and Philadelphia

# Margaret A. (Peggy) Browning

A Beacon for Workers' Rights

Our namesake was, by all accounts, an exceptional person whose life and qualities left their mark upon the legal community and on the national scene. Born in Tennessee and educated at Swarthmore and the University of Pennsylvania Law School, Peggy was a creative and dynamic attorney.

While her name could have graced the masthead of any mega law firm, she chose to devote her energies to workers' rights. In her defense of workers' interests, she never lost a case in the Third Circuit Court of Appeals. Peggy was tirelessly focused on issues such as union representation, fair and equal pay and decent working conditions.

Her achievements strongly justified President Clinton's nomination of her as the first union-side lawyer in history to be appointed to the National Labor Relations Board.

The Peggy Browning Award is presented annually to social justice champions who have distinguished themselves with passion and dedication to the rights and needs of workers and their families.

events occurred on schedule, but the pandemic resulted in the cancellation of the June Washington, DC event and the postponement of the April New York

event to September 30th. Given the widespread predictions for a second wave of infections in the fall, our largest event in New York will be virtual. In short, PBF faces the loss of anywhere from a quarter to more than half of our projected event income. We are attempting to limit this loss by raising funds electronically, but it is clear that PBF must increase receiving donations from our supporters.

# PBF Alumna Fights for Black Lives Protesters

And PPE for Essential Workers



2011 PBF Alumna, Sonya Z. Mehta, is now a partner at a civil rights firm in Oakland, CA. Her Peggy Browning Summer Fellowship was with UNITE HERE Local 2 in San Francisco. Sonya credits her PBF Fellowship as having helped her to continue to work as an activist lawyer. Now, she and her firm

continue to fight for justice and equality for all.

Most recently, Sonya's firm filed a lawsuit to protect the amazing protest actions and solidarity movement for Black lives in the streets of Oakland this past May and June. Over several days, the police indiscriminately tear gassed and shot projectiles into peaceful crowds. The lawsuit seeks to enjoin the Oakland Police Department and 'mutual aid' law enforcement from using these chemical weapons, 'less-lethal' bullets and projectiles, and other dangerous tactics against protestors. It also seeks damages for the many people injured by the police. They won a temporary restraining order limiting police use of these war 'toys' and now move forward towards a permanent injunction.

Sonya's firm has also been at the negotiating table for SEIU Local 87, the San Francisco janitors' union, as they fight for personal protective equipment and other fair conditions in this age of COVID-19. She is making sure employers treat them like the 'essential workers' that they are. In addition to these historic fights, Sonya continues the legal work against employment discrimination, for whistleblowers, and against police brutality in their other cases.

A rising third-year law student at American University Washington College of Law (WCL), Autumn was awarded a Peggy Browning Fellowship at Mehri & Skalet, PLLC in Washington, DC. This experience enabled Autumn to put into practice the knowledge she obtained during her Employment and Labor class in law school.

This summer, Autumn worked on several exciting employment-related cases. For example, she supported the firm's efforts in advocating for employees who lost their jobs due to COVID-19 related circumstances. Autumn also worked on class action litigation related to employees who faced sexual assault and harassment in the workplace and on a class action suit where employees were denied promotions and raises because of a discriminatory evaluation system.

Despite working remotely due to COVID-19, Autumn developed professionally by attending brown bags organized by the firm and virtual panel sessions organized by PBF. She is excited to apply what she has learned this summer towards her next endeavor as a student attorney at WCL's civil advocacy clinic, where she will represent low-wage workers in cases against exploitative employers.

The Wage Justice Center in Los Angeles, CA continued to enforce judgment liens and mechanics' liens to secure worker-creditors' debts from employer-debtors in the middle of the coronavirus pandemic. Although they could not meet their clients directly, they were still able to conduct calls and keep them updated so they could secure economic relief through the payment of their stolen wages. Arturo's personal work experience

was in assisting in facilitating these discussions by scheduling the calls and conducting legal research to help their clients and to change the law long term.

On the legal research side, Arturo was assigned to work in conjunction with a PhD candidate from UCLA. He studied due process issues, raised against other states' mechanics' lien statutory schemes, in order to better understand how this helpful information could be applied towards forming a wage lien for California. In addition to longer-term policy research, he also conducted legal research for specific cases to assist in the office's preparedness in helping their clients.

"The pandemic may have dealt a blow to the working class' well-being," noted Arturo, a rising third year student at Southwestern Law School, "but our solidarity with their struggle, and our shared fight against those who seek to exploit and abuse them only strengthens."

As a PBF Summer Fellow at Levy Ratner, PC and a rising third year student at the University of North Carolina School of Law, Cayla describes her experience as having had the immense privilege of advocating for workers' rights during a time when workers have needed it most. Whether it's demanding the correct pay during emergency paidleave due to COVID-19, challenging an employer's discriminatory practices, or advocating for broader policy changes - she has seen unified workers make it all happen.

One of her favorite long-term assignments this summer was one that put her in direct contact with employees and their delegates to discuss work conditions and treatment during the pandemic. This allowed her to better understand the needs of workers while also learning that her role as a fellow, and eventually as an attorney, is to make sure she's listening to those needs so that she can transform her role to best support organizers.

Cayla shared, "I am extremely grateful to both the Peggy Browning Fund and Levy Ratner, PC for giving me this opportunity and I am excited to take my new skills and continue to work within the labor movement."

A second year student at the University of Michigan Law School, Jeff Wang was awarded a Summer Fellowship at the Communication Workers of America (CWA.) He worked on a wide variety of interesting assignments, with topics ranging from unfair labor practices to intellectual property. As a result, he observed how union attorneys support the labor movement, including workplace organizing and collective bargaining, community mobilization and political advocacy, and internal

operations and governance. One of his favorite assignments dealt with defamation and involved a wealth of interesting case law.

Jeff felt fortunate to work with a wonderful legal team at CWA. The attorneys and staff created a warm and open environment for him and his co-clerks despite their remote locations, which included virtual mentorship chats, department meetings, and happy hours. In addition, his union helped him participate in a valuable twoday conference for students of color interested in labor law, hosted by the AFL-CIO Lawyers Coordinating Committee.

"Overall, my Peggy Browning Fellowship reinforced my desire to become a labor movement attorney and provided me with a great experience to carry forward in my life and career," said Jeff Wang.

front and center actually than any time since the 1960's. There are actually 300 law firms in the U.S. representing unions and 2,000 attorneys, and it's critically important that there continue to be committed young lawyers in the pipeline. PBF is part of that pipeline."

The final award of the evening was presented to Jason Rabinowitz of IBT. "The great thing about the PBF at this moment is that it looks to the future of labor. We need to look at the future in this movement because everything that we built, everything we've accomplished is under attack and under threat today."
