I was awarded a Peggy Browning Fellowship with the

American Federation of Government Employees (AFGE) in Washington, DC. Specifically, I worked in the Women's and Fair Practices Departments, Legal Division of AFGE. This fellowship allowed me to put my passion to action.

The Women's and Fair Practices Departments focus securing on women's rights regarding family and medical leave, equal pay, childcare, sexual harassment and domestic violence. Not only does the department operate from a reactive standpoint on discrimination issues, but it takes proactive measures to advocate for change and train employees to comply with equal employment opportunity laws through educational materials and departmental reports.

In addition to reformatting and editing several of AFGE's publications, preparing and labeling exhibits for hearings, researching and building strong arguments for complainants' cases, I created a presentation on the EEOC and Alternative Dispute Resolution procedures, wrote an article for the EEOC *Advocate* on criminal background checks and attended a panel discussion on EEOC Initiatives at EEOC headquarters.

This summer, I attended two rallies on Capitol Hill, something that was a new experience for me. The first was to advocate against pay downgrades for the lowest paid veteran government workers. AFGE sent the entire office to attend and rally for those who had served our country and for which budget cuts were severely impacting.

The second was for the reauthorization of the Violence Against Women Act. The Senate had passed a version with all-inclusive protections, while the House put politics ahead of protecting victims of domestic violence by excluding LGBT victims, women on Native American reservations and some victims on college campuses. We attended in support of the all-inclusive version of the bill. The rally included speakers such as Congresswoman Gwen Moore of Milwaukee, singer Michael Bolton, and Virginia Tech student and survivor of the Virginia Tech shooting, Colin Goddard.

This experience has solidified my desire to implement positive change through the law. My mentor was a wonderful role model for honesty and integrity in the legal profession. I believe I had a well-rounded summer!

Our namesake was, by all accounts, an exceptional person whose life and qualities left their mark upon the legal community and on the national scene. Born in Tennessee and educated at Swarthmore and the University of Pennsylvania Law School, Peggy was a creative and dynamic attorney.

While her name could have graced the masthead of any mega law firm, she chose to devote her energies to workers' rights. In her defense of workers' interests, she never lost a case in the Third Circuit Court of Appeals. Peggy was tirelessly focused on issues such as union representation, fair and equal pay and decent working conditions.

Her achievements strongly justified President Clinton's nomination of her as the first union-side lawyer in history to be appointed to the National Labor Relations Board.

The Peggy Browning Award is presented annually to social justice champions who have distinguished themselves with passion and dedication to the rights and needs of workers and their families.

Next Generation Fired Up for Workers' Rights

Students from 82 Law Schools Find Inspiration and Critical Connections

Perfect fall weather on the impressive campus of the Conference Center at the Maritime Institute near Baltimore provided the setting for PBF's National Students Workers' Rights Law Conference on October 12 & 13. A year's worth of work by dedicated members of our Conference Planning Committee provided the framework. Nearly 200 students and leading practitioners of labor law provided the energy and enthusiasm. It's no wonder that our conference was another huge success!

The conference began on Friday with the Fellowship Luncheon & Wrap-Up Workshop. This brought together students and mentors to describe their summer assignments, to discuss the various worker rights issues faced by their clients, and to brainstorm ways in which they can become a cohesive group that will have an ever-widening impact on the labor movement.

Another pre-conference session was a Congressional Staff Briefing on Labor Law and Policy on Capitol Hill. Students met with labor lawyers from

Each briefed the students about their work, how to get a job doing labor law on Capitol Hill or as a labor lobbyist, what that work entails, how a law degree helps with legislative work, and much more.

Saturday's Keynote Speaker, NLRB Board Member Richard F. Griffin, Jr., not only inspired students as he described his own career path but also generously stayed on afterward to spend time with every one of a long line of students seeking individual career advice.

Workshops on Saturday covered basic labor law, public sector labor law,

My primary task was to assist the union's General Counsel and work with former Peggy Browning Fellow **Martin Milz**, and others at the labor law firm of Spear Wilderman, PC, with various labor disputes and research. Because I had an office at the union hall, I also often assisted business agents and organizers with labor and management negotiations, organizing legal demonstrations, hand-billing and elections.

Coming from a pro-union family, I've long understood the unions' fight to empower the middle class and provide the opportunity to achieve the American Dream. Over the course of my fellowship, I had the privilege of serving men and women who buy only American-made products, drive only American-made cars and fight like hell to put people to work. What could be more American than that?

My presence at NELP brought the total Seattle office number to two, so it was hard to believe I would get to know the players and their stories from that office on an obscure side street in Little Saigon. NELP's approach to policy work, however, allowed me a front-row seat to organizing work around the country.

I ended the summer with a sweeping perspective of the struggles waging across the country on behalf of immigrant workers, and a strong sense of the groundwork of these struggles from experience close-up in Washington state.

My summer fellowship experience was exciting, rewarding and fun! All of the attorneys at LIUNA took a special interest in the fellows, and we were able to work on a diverse set of projects and benefit from supervision and mentoring from a number of sources.

My goal was to see for myself what the labor movement was like from the inside. I was not only reassured by what I saw, but being immersed in a community of solidarity and commitment to social justice was a rewarding experience. The Summer Fellows were invited to participate in a march for VA workers. I was amazed to see the LIUNA office workers become activists as soon as they exited the building. I marched alongside my co-workers chanting and clapping in solidarity with the VA workers.

This day drove home the idea that we were a part of something bigger than the sum total of the work we had accomplished together. It reminded us that we were partners with the working men and women of this country in their struggle for fair pay and decent conditions.

This summer, I hoped to expand my knowledge of how the NLRB operates in everyday life by handling my own cases with the help of a mentor. I was not disappointed. From the very first case, I felt like I was given the opportunity to do real work that impacts the lives of real people.

The case of a union truck driver will always stand out to me. After explaining the law to his employer, I was successful in getting the driver back to work. The case had many facets and a lot of substance – not the typical case an intern handles. This man had been so worried and stressed, it was an amazing feeling to know that I was able to use my knowledge and fellowship position to help him. I was nervous, but my mentor supported me and kept me going down the right path.

were being denied a fair chance to compete for a firefighter job because of a discriminatory entrance exam. I returned phone calls to hundreds of potential class members to inform them of the current case status and to explain the judge's recent proposed order of relief in plain English.

Also, when ConEd locked out utilities workers, our office buzzed with strategy. All were encouraged to stop by the picket line to show solidarity. One afternoon, a group of us joined Utilities Workers Local 1-2 at a rally in Union Square. The entire summer felt vibrant and exciting!
